#### I. CALL TO ORDER

A. - B. **Vice President.** Shawanda reported an increase in membership dues from 21 to 40 paid as of August 17<sup>th</sup>, 2022. Shawanda encouraged those who have not paid to pay their dues online. Shawanda communicated the various payment methods available: PayPal, Cash app cash.app/\$millerspointna, cash or check or money order mailed to MPNA, P.O. Box 2412, Universal City, Texas 78148. Checks and money orders should be made payable to Miller's Point Neighborhood Association or MPNA. She facilitated how to make payments online, visiting the neighborhood website at millerspointna.org via using their smartphone or tablet by clicking "Donate Now".
- C. **Treasurer.** Magdalena Thomas presented the financial summary starting from last year December 31, 2021, with a balance of \$2,964.47. This year's expenses as of October 17, 2022 were streetlights \$3,281.80, website \$200.00, P.O. Box rental \$156.00, Expertees t-shirt payment \$577.52, raffle gift prize \$100.00, and yard signs for Neighbor National Night Out \$464.23 and the total of expenses were \$3,779.64. The income was memberships and donations of \$2,145.13. This year's income as of October 17, 2022 were NNO raffle tickets sold \$139.37. Allan Thomas secured a \$100.00 gift card from Walmart and purchased hamburgers and donated the hotdogs, which was an additional \$12.00 and the balance for the gift card was \$55.17. The funds were deposited into the bank. T-shirts sold \$854.92 and dividends .75 cents. Then in October, we had \$3,195.27. We have a loss for the year of \$584.35 and the current balance for the year is \$2,382.12. There was a donation for the sign from Elizabeth Thomas \$96.62 and Allan Thomas \$45.00 and the total for the sign of \$149.62. Gwendolyn expressed our thanks to Commissioner Calvert and Precinct 4 for the \$500.00 donation in participating in our fundraiser at the National Night Out. The donation will pay two months of the CPS utility bill.

#### VI. COMMITTEE REPORTS

- A. **Junk & Brush Committee.** Shawanda announced the Junk and Brush is scheduled for Saturday, Nov. 5<sup>th</sup> and Sunday, Nov 6<sup>th</sup> from 9:00 a.m. and 5:00 p.m.
- B. **Sign Committee.** Elaine Miller communicated that her team is scheduled to start their meetings next week and she will provide the location.

#### VII. OLD BUSINESS

- A. **Need Volunteers** to sign up for Junk & Brush, Crime & Safety, Block Captains, Social & Media. Shawanda encouraged members to sign up as Block Captains for their street and expressed the importance of the association needing Block Captains to help get our neighbors involved and disseminate information by distributing flyers and brochures.
- B. **Solar Lighting/CPS Energy.** Gwendolyn Bolden highlighted the funding that is earmarked for 2023 budget is for the SOLAR project for 19 streets that do not have lights. Joe Gest asked a question about charging each resident on their CPS bill. Gwendolyn communicated she brought this question to Commissioner at Commissioners Court and CPS is not willing to foresee as a possibility.
